Workshop organised on

“Cyber Crimes: Securing the electronic communication”

on **Saturday, 9th April 2011** from **9.30 AM to 5 P.M.**

at **Image Auditorium M.R.C. Nagar, Chennai 600028.**

Shri R. Ramamurthy Chairman, welcoming the guests and participants spoke briefly on the activities of CySI and highlighted the significance of the workshop. Shri M.R. Sivaraman, IAS (Retd) former Union Revenue Secretary and former DGCA and Exe Director I.M.F. inaugurated the workshop. He presented the various forms of cyber crimes and lauded the efforts of CySI in creating awareness on the vulnerabilities in an e-communication. Shri N. Vittal former Central Vigilance Commissioner, briefly spoke about the contribution of CySI in the area of creating awareness about cyber crimes and drawing from his experience in the area of computerization highlighted the importance of technology in crime prevention and crime detection. Shri M.S. Sundara rajan, former Chairman and Managing Director in his special address spoke about the level of computerisation in banks and the necessity to educate the public and customers about the fraud-prone areas in technology.

Shri V Rajendran, Cyber Law Consultant and Secretary Cyber Society of India addressed the participants on “Id theft and Corporate espionage”. He went into the entire gamut of data privacy, data piracy, id theft and how hacking has evoked interest among the youth and how technology (like steganography) is being used, misused as a profession illegally as a tool in espionage and spying. Dr B. Muthukumaran in his presentation spoke about bots and zombies and the threats posed by malware and other similar attacks in a network.

Post lunch, Shri A Vijayakumar Asst General Manager of Karur Vysya Bank chaired the Panel Discussion on “Securing the electronic communication in different fields”. Security aspects in UIDAI “Aadhar” project were presented by Shri Sharma Asst Director General UIDAI and Shri Omprakash Subba rao, its Technology Consultant. Security aspects on Social Networking sites were presented by Shri K. Srinivasan CEO of Prime Point Foundations. Smt S Panchi, Senior Manager I.T. Dept, IOB, gave a presentation on the security aspects in net-banking. Shri V Vikayakumar CEO of Qadit Systems and Solutions gave a lecture on security aspects in corporate communication.

Shri S.N. Ravichandran CEO of Nilagiri Chemicals and Co-ordinator of CySI Coimbatore Chapter spoke on the practical problems in investigating a white collar crime. He spoke at length on the importance of log and log analysis in Mobile communication, KYC records in banks etc.

There was a lot of interaction with participants from institutions like Bank of Baroda, Capgemini, Indian Bank and AIBEA raising questions on the topics discussed and contributing towards the deliberations in a purposeful manner.

The day concluded with Vote of Thanks and summing up by Shri R Murugan Life Member CySI.

After the workshop, CySI conducted its Board Meeting and General Body Meeting at the same venue.
