ORDER :

The Secretary of the society, "The Planters' Association of Tamil Nadu", Coimbatore (Reg.No.149/2004), in the representation first read above has stated that the said society has been registered under the Tamil Nadu Societies Registration Act, 1975 on the files of the Registrar of Societies, Coimbatore District and having members hailing from several parts of the State. He has also stated that section 26 of the said Act requires that atleast one general meeting of the society shall be held in a year. A prescribed quorum for resolutions/ decisions being adopted in such a meeting is also required and these conventional requirements might turn out to be far-fetched in a scenario of imminent viral outbreak, where people would be unwilling to venture out for any such closed door meetings in air conditioned settings in many areas. He has further stated that the annual general meetings of the societies registered under the Act, in respect of the year 2019-2020 are to be held before the 30th September 2020 and therefore requested the Government to bring about statutory changes in the Act empowering the conduct of meetings through virtual or electronic platforms or through postal system.

2. As per section 16(3)(a) of the Tamil Nadu Societies Registration Act, 1975 read with rule 22 of the Tamil Nadu Societies Registration Rules, 1978, every registered society shall within six months after the expiration of the financial year to which the accounts relate to, place before the general meeting the receipts and expenditure account and the balance sheet of accounts duly signed by the auditor or the members so appointed by the society and the members of the committee.

In view of the above mentioned provisions, the societies registered under the Tamil Nadu Societies Registration Act, 1975 have to place their receipts and expenditure account and the balance sheet of accounts for the financial year 2019-2020 before their general body meeting to be conducted within the month of September 2020.

3. In view of the spread of COVID-19 pandemic, the Government have examined the request of the society "The Planters' Association of Tamil Nadu", Coimbatore (Reg.No.149/2004) along with the provisions of Tamil Nadu Societies Registration Act, 1975 and have decided to extend the time limit prescribed under rule 22 of the Tamil Nadu Societies Registration Rules, 1978 by a further period of 3 months. Accordingly, in exercise of the powers conferred by sub-section (2) of Section 54 of Tamil Nadu Societies Registration Act, 1975 (Tamil Nadu Act 27 of 1975), the Governor of Tamil Nadu hereby grants extension of time limit prescribed under rule 22 of the Tamil Nadu Societies Registration Rules, 1978 to all the registered societies for a further period of three months i.e. up to December, 2020 for placing the receipts and expenditure account and the balance sheet before the general body meeting, for the financial year 2019-2020.
